Works to create a new narthex and glazed internal entrance door. Works include:

- 1. The removal of a total of 6 pews, removal & disposal of bookcase, re-siting of altar cloth storage unit to within choir stalls and the re-siting of wooden coat hooks & screen, to create a new Narthex at the rear of the church, with the installation of a new full length glass screen including 2 glass doors allowing entrance to the aisles of the church, framed with matching wood to original. The new area to be carpeted in the same red colour as current carpet. Existing monuments of list of vicars, history of the building of the church and Paul Wells memorial to be retained and moved into the nave. All walls to be repaired if required using the correct materials for the building and painted the same colour as existing.
- 2. Creation of a tea station along the west side of the church made from the wood of the removed pews. Any unused pews to be sold.
- 3. Removal of existing internal painted wooden entrance doors and replacement with new glass doors which open inwards. Installation of a wooden ramp in the porch to allow for a fully accessible entrance.
