# **Archdeacons' Visitations**

# **Annual Parochial Church Meetings**

You should by now be aware that the Church Representation Rules have been updated. The most significant change is that APCMs must now be held before 31 May rather than the end of April, as we are sure you realise. The new rules can be found at <u>https://www.churchofengland.org/more/policy-and-thinking/church-representation-rules.</u> Parish Resources has a <u>handy checklist</u> which is useful to help keep abreast with governance matters, including whether trustees (PCC members) are eligible to serve.

# Elections

The various requirements relating to elections of Churchwardens in readiness for the Visitations are detailed below.

All the documents you need in preparation for the Admission of Churchwardens are on the <u>Diocesan Website</u>. These include links to the Churchwarden's nomination form, and the template for the Churchwarden's Declaration. We do not need to receive a copy of the nomination form.

### **Churchwarden Declarations**

As last year, you will complete your declaration at the visitation on the form provided there and give it to your area dean. This will be the only record that you have been sworn in at a visitation, for recording on our database. Please bring a pen!

As you can imagine, it is a time-consuming task to check and enter the personal data you have previously provided on the declaration form for all wardens onto our database (CMS). We are again requesting that wherever possible, you check and update your information electronically. To do this, after the visitations, you will receive an email with a personal link together with instructions of how to complete the process. Many of you used it last year, and the system has been used to good effect in other dioceses; it means there is less margin for error. We hope this will be straightforward for you but you can of course email us your personal details and privacy settings using this form, link here.

If you do wish to complete the familar declaration form, please note that because of numbers attending the Visitations on the day, it will not be possible to collect any paperwork on the evening. We would appreciate receiving any documentation electronically, by email. If this is not possible, please could you post it to the office, address above.

As a Diocese, we need to make sure that we comply with the General Data Protection Regulation 2018. If you have not yet completed a <u>consent form</u>, please could you complete and return it. Otherwise, you can amend your privacy details on the online form.

# Attendance at the Visitation

This year, we are inviting wardens and incumbents only; if under exceptional circumstances you are unable to attend a Visitation then please let your Archdeacon's PA know as soon as possible. There is no requirement this year to bring your staves.

We suggest that there is an acknowledgement of your office at your parish service following the Visitation. This could also be an opportunity to admit your sides people who unfortunately cannot attend the Visitation service this year. A liturgy has been provided for this, which is on the diocesan website.

We would encourage car sharing for those attending from a parish together; if expense is an issue, then trustees can legitimately reclaim travel expenses from the PCC.
