## What is Stewardship?

## Why should I give?

As Christians, we give as a sign of our love for God and in response to God's love and generosity to us.

Christian Stewardship means seeing our lives and possessions as a gift from God to be used in God's service. We should live in the knowledge that we are stewards, or managers, of everything God has given to us (time, skills, money, and possessions), knowing that we will be accountable to God for how we have used these.



In Vision 2026, one of the marks of a Healthy Church is one where people are "Giving generously of our "Yours, Lord, is the greatness and the power and the glory and the majesty and the splendour, for everything in heaven and earth is yours"

1 Chronicles 29:11

time, talents and money to the cause of Christ".

Stewardship is not about giving so the church can "make ends meet" but about generously giving back to God and seeing God's church grow as it is resourced for mission and ministry.


## How much should I give?

# How do I know if I'm giving generously?

- Is the amount I'm giving away realistic in relation to my income?
- Can I see an element of sacrifice in my giving? Does it impact on my lifestyle?
- Is my giving a priority from what I receive each week or month, or just what's left over?
- If what I give away was given back to me, would I notice?





## What is Stewardship?

## How should I give?

Giving that is planned and regular helps the church to budget and to know that it

STANDING ORDER MANDATE



The easiest ways to give regularly are by:

- Standing Order/Direct Debit or
- Weekly Giving Envelopes or
- Payroll Giving (If your employer offers this)

If you pay tax and have completed a valid Gift Aid declaration, HM Revenue and Customs will let your church reclaim the tax that you paid on your offering.

The basic rate of income tax is currently 20%. When you give under Gift Aid the church can claim back income tax of 25p for every £1 you give.

# **Legacies – A Lasting Difference**

We are called to be stewards (or managers) of everything that God has given to us throughout our lives. Therefore, we should also consider including a gift to our local church in our will. Through the Book of Common Prayer, members of the Church of England have been encouraged to make a will as part of our lifelong

stewardship for more than 350 years.

# **Section 2: income and expenditure**

These charts are based on accounts prepared for the last three years for the General Fund, with some income and expenses netted off to give a simpler picture. The charts only include the unrestricted funds. The aim is to enable a simple view of the main elements of the income and expenditure and the changes year on year.





Section 2: income and expenditure





Planned Giving fell from £47,300 in 2018 to £44,400 in 2019 but in 2020 increased very slightly to £44,500 though still below the 2018 figure.

However, over the same period, unplanned giving fell in 2019 and 2020.

In 2019 Total Giving fell by £2,200 to £53,800 but in 2020 it increased to £55,700, though still below the 2018 figure of £56,000.


The remaining unrestricted income is mostly made up of tax refunds, fees, donations, and fundraising income

Total (unrestricted) Giving of £55,700 plus tax refunds of £12,550 totalled £68,250 in 2020 and represents 74% of the total unrestricted income of the parish of £92,650.

# Section 3: Attendance and giving


Based on figures provided by the parish as their annual returns of mission and finance, Usual Sunday Attendance is shown in the table below and the graph at the right.

Adult attendance has been falling. It fell from 79 in 2012 to 65 in 2013. It then stayed relatively stable and was 61 in 2019. However, by 2020 it had fallen to 51 in 2020.



Child attendance has been much more stable – and in 2019 was at the same level as 2012, though fell by 3 in 2020 to 17. In 2020, child attendance at 17 was 1 in 5 of total attendance.

## **Giving and Parish Income**

Planned giving in the parish has also fluctuated in recent years. The table and graph below are based on the number of planned givers included in the annual returns of parish finance and the planned giving included in the accounts.

The diocesan and deanery figures are shown on the graph on the left and the table above.

The number of planned givers fell in 2016. It increased in 2017 but not back to the 2015 level and has fallen each year until it is now 88.


The average per planned giver per week increased in 2017 to £10.02 but then fell again and was £9.72 in 2020.

The above graph is a summary of the total planned giving in in the year to 31 December 2020 (but cannot be tied up to any other sections of this sample report). Where giving is from a couple, they are counted as two givers each giving 50% of the total for that couple.

The planned giving profile offers an insight into the pattern of giving in this church. The charts on the page cover all planned givers — both those whose giving is under Gift Aid and those who do not or cannot Gift Aid their gifts.

As envelopes are not always received every week, the total received over the year is divided by 52 to arrive at an equivalent weekly amount. The amounts are based on what is <u>actually</u> given but may be less than people <u>feel</u> they give.

In 2020, out of the 76 people represented by planned giving:

- 4 out of every 9 (34) gave less than £3.00 per week
- The largest number (19) gave less than £1 per week and the next highest (12) gave between £5.00 and £7.50 per week
- Almost ¾ (55) used standing orders and 21 used planned giving envelopes.
- All used Gift Aid.
- The average giving was £4.51 per person per week.
- More than half gave less than £3.46 per week.
- Excluding the 7 who give between £10.00 and £12.49 per person per week, the average giving would be £3.83 per person per week.
- A further £457 was given by members in one off gift aid envelopes, but this is not planned giving so is excluded from the figures above.

# **Section 4:** Giving Analysis

• £2,016 was given by 142 people who are not attending but using one off envelopes. Though valuable, and indicating support from the community, this has also been excluded from the planned giving analysis to focus on those who attend.

The planned giving of regular givers is almost certainly the single biggest source of church income. Accordingly, understanding and nurturing the growth of planned giving is the primary stewardship task.

It's often said that 'Everyone here is giving all they can'. In truth, in almost every congregation, much of the giving is from the generosity of a few while many give rather less than we or indeed they might think.

In most churches a small number of people give a large proportion of the total giving to the church. This pattern of giving is called skew.

The chart on the right shows to what extents this church is dependent on a small number of givers

- 10% of planned givers (8) give 24.5% of the money given through planned giving
- 20% of planned givers (15) give 44.3% of all that's given through planned giving.

To understand our giving better we need to look deeper. We need to know our dependence on a smaller number of regular givers and to be confident that when asking people to give more we are not asking the impossible. Please don't assume that lower level giving simply reflects income levels. Some people are indeed giving sacrificially but by no means all. In many cases, when asking for greater giving we are not asking the impossible.

# **Questions**


- 1. What does our giving profile tell us about giving in our church and are there any surprises?
- 2. We sometimes say that everyone is giving all they can. Does our giving profile suggest this is true?
- 3. Do we create opportunities for folk to review and renew their giving through an annual review and regular stewardship programmes?






The Unrestricted Fund is made up of the amounts shown below and on the right and the overall balance has been increasing.

Our pattern of income and expenditure and our reserves should provide a sustainable base for effective ministry and mission in the place God has called us to serve.

When God does something new in the Bible, his people respond with financial generosity. The people brought Moses too many gifts for the tent of meeting (Exodus 36:4-

7) while David's generosity inspired the generosity of others when building the first temple (1 Chronicles 29:1-9). As Nehemiah rebuilt Jerusalem's walls there was a fresh commitment to sustain the worship of the temple: we will not neglect the house of our God (Nehemiah 10:39).

Our challenge as God's people in the place he has called us is to resource adequately, even abundantly, our church's ministry. Indeed, the generosity of women of means made possible Jesus' own ministry (Luke 8:1-3).

## **Questions**

- 1. Is there a general trend and how might our finances look in five years if we keep going as we are?
- 2. Can we explain what we see any spikes or dips in income and expenditure?
- 3. Has the church council agreed a reserves policy and told the church what it is what we should keep in the bank, why, and how we decide what to spend?
- 4. Is there a group which oversees stewardship for our church?

#### **Section 6: Conclusions**

Based on the amounts included in the accounts, the shortfall in recent years can be broken down as shown below

Every additional £5,000 that the parish needs, is equivalent to a weekly amount of

- £1.89 per adult attender (based on Attendance of 51 in 2020 see page 6)
- £1.09 per person per week (based on 88 planned givers see page 6)
- £1.27 per person per week (based on 76 planned givers see page 8)

# How do I know if I'm giving generously?

- When I look at my giving in relation to my income, is the percentage I'm giving away realistic?
- Does my giving in all its forms have an impact on my lifestyle? Can I identify an element of sacrifice to my giving?
- Is my giving a priority from what I receive each week or each month, rather than what's left over?
- If what I give away was given back to me, would it make a real difference to me? Would I notice?



To help build a generous church, we need to look both at practical issues (Giving Practice) and also ensure the culture within our church is one of generosity.

Below are four things that relate to giving practice and four relating to giving culture. Why not focus on one of these at each PCC meeting over the next year and ask yourselves the following 3 questions for each of the 8 categories:

- What are we doing well?
- Where do we need to improve?
- What could we do?

## **Giving Practice**

#### 1. Mechanisms

This is about the ways people give. The easier it is to give, the less 'friction' there is in giving, the more likely people are to give. The way people use money is changing, and that means the way people give is changing too, and we need to acknowledge that in the mechanisms we offer. Good practice here is all about providing the ways to give in an accessible, simple, straight forward way. It's also about ensuring that whatever way people give, they are thanked for their gift.

- Can you think of a time, in church or in another context, when you wanted to give but couldn't?
- How do you normally give outside of church? Is it different?
- What is your preferred way of giving? How about a younger visitor?>

## 2. Impact

To encourage people to give, we need to explain what will change if they do, the impact. We often talk about costs, but that often makes people think their giving is insignificant in comparison. Impact should be shown clearly in our mission and vision plans. Good practice is showing what impact the church has made consistently throughout the year through all communication methods (leaflets, talks, social media stories, website etc).

- What have people told you about what your church has done for them?
- What does your church do that has made the greatest impact on you?
- Impact is about outcomes not outputs. Running a 'messy church' is an output, whereas enabling 12 children to learn about God is an outcome. Think about what the church does and try and explain it by describing its outcomes (impact) not its outputs.

#### 3. Need

People sometimes assume the church is wealthy and doesn't need their support, but voluntary income pays for 75% of the costs of the church's ministry and mission, so people need to give so the church to do what it

does. Members need to understand cause and effect –if people do not give, what will stop? They need to realise the urgency for people to give and be convinced of their own responsibility to give. Being aware of the need to give is crucial to people choosing to give.



- What would not happen if people gave 10% less?
- What could happen if people gave 10% more?

#### 4. Trust

When people give, they have to trust the people they are giving to. Trust that the money will be carefully spent, that it will be spent on what they said it would.




They must also have trust that the work it is spent on will be consistent with and live out the faith that motivates the gift. Trust is woven into all aspects of giving, and as leaders we need to show ourselves to be worthy of that trust, and make sure we keep it.

- Which organisations do you trust? Why?
- Has there been a time when you trusted someone, and they let you down? How did that feel?
- Think of a person that you think is trustworthy. Describe them and say why you think they inspire trust.

#### **Generous Culture**

## 5. Inspire

Generous churches need generous PCCs, showing generosity in the decisions they make and the way they act. All church members, whatever their age, need to be inspired to live more generous lives.





transforming grace of generosity lived out. We need generous and hopeful visions, plans and strategies to inspire us. We all have a role to play in inspiring others, in encouraging each other to keep making tentative steps forward in living more generous lives.

 Think of someone who you think is generous. How do they live generously?

## 6. Disciple

We all learn in different ways, and so we need different ways to learn about living generously. Giving is a subject we often find difficult, and it is easy to become defensive, and to feel criticised, condemned or judged. All methods of discipling people on generosity (individual or group study or preaching and teaching) need to be encouraging, positive and supportive.



What is it to be a disciple? In Mark 12 Jesus says it is to love God and love our neighbour. This requires a complete generosity of spirit, and graciously God sees we cannot attain it by ourselves. Generosity is itself a spiritual gift, and we should start by praying for the gift of generosity, and that we be constantly refreshed with the re-realisation of God's generosity to us.

- Describe the way you think you learn the best. How could you learn more about generosity this way?
- Why do so many people prefer not to talk about money? How can we talk about it in a way that people find comfortable?

#### 7. Embed

Generosity and giving should be embedded in the church's ministry and



mission. Everyone can give something and giving needs to be seen as intrinsic to being part of the church community, embedded in our planning, mentioned in every service, forming part of our welcoming of new members, in a way that reflects our own church culture.

There are more bible verses on money, wealth and possessions (2,350) than anything apart from love, with four times more than on faith or prayer. Nearly half of the parables are about money and possessions. Whilst we as a church often hate talking about money, Jesus never stopped. The way we use the money God has given us is so important in bringing the love of God to our communities. Embedding generosity in all we do makes us more and more like the generous God we believe in.

- Think of adjectives you think other people would use to describe your church. Would generous be one of them?
- How are new members of the church welcomed into the church. Do we mention giving as part of that?

#### 8. Activate

People often want to build a more generous life, but they don't know how to build it. We can provide the scaffolding for this learning, giving practical ways to grow generosity.

"I by my works will show you my faith" (James 2:18).

Generosity is a spiritual gift that needs practice. We need
to be able to live it out, not just to ponder it. It is a way of being, not just a
way of thinking. By giving people the opportunity to grow a more generous
life, we give the opportunity to deepen the faith that sustains it. Generous
churches are inevitably growing churches., they can't help it. Their
generosity spills out, as they share the overflowing life and love of God.

- Have you ever set yourself a goal and a plan to achieve it? It could be fitness, diet, a new skill, a qualification. Talk about how you planned it and how it felt when you achieved it.
- People often find it easier to do something new if they do it with other people. Is the same true of being more generous?
- How do you encourage people to do something without making them feel guilty if they don't?

- Offering Worship in Spirit and Truth through the Ministry of Word and Sacrament


